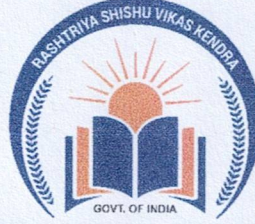

Rashtriya Shishu Vikas Kendra invites online applications from eligible Indian citizens for appointment to the Teachers & Coordinators Posts on Permanent Basis. Candidates are requested to apply online through the link given on Rashtriya Shishu Vikas Kendra official websites www.rsvk.in.

Under Article 21'A' of the Constitution right to education, health and nutrition is a fundamental right for all children between the age group of 03 to 07 years. This provision was added by the 86th Constitutional Amendment in 2002, under which the Central Government provides free and compulsory education to children in the age group of 03-07 years. For this, it has become necessary to adopt programs of comprehensive expansion and improvement at the primary level, there is a need to open new primary education centers in the education system of the state and there is a need to employ a large number of Teachers. Therefore, this rule has been made to fulfill this purpose. Under the special scheme, preparations have been made to open new elementary education centers and teachers will be appointed.

Currently Job opening in Rajasthan, Jharkhand, Uttar Pradesh for the Post Teacher & Coordinator. The date and other instructions for filling the online application form are given below.

1.	Starting date of online application	16/03/2026	
2.	Last date for filling online application	17/04/2026	23.45 Hrs.

- The process of registration is completely free. There is no need to make any payment to the department for this all candidates will submit their application free of cost.
- Before applying candidates are requested to ensure that they fulfil the eligibility criteria for the Post(s) as on the date of eligibility.
- Candidates must upload all relevant documents including their identity card, educational qualification certificates etc.; otherwise their application/candidature will not be considered for Selection/Interview.
- Verification of original documents will be done at the time of appointment. Confirmation of candidature will be subject to verification of all details/documents.
- If the candidate does not fulfill the eligibility criteria (age, educational qualification etc.) he/she will not be allowed to appear for the interview.
- Candidates are advised to check Rashtriya Shishu Vikas Kendra official website www.rsvk.in regularly for details and updates.
- Candidates will apply for one post, otherwise applications of candidates applying for more than one post will not be accepted
- Candidates are not required to send the hard copy of the application form and related documents to the Commission office. If the application or any supplementary document is submitted in hard copy by the candidate himself, then that hard copy application/document and any claim made on its basis will not be accepted.

ESSENTIAL QUALIFICATION:

1. Primary Teacher
 - Only for Indian Citizen.
 - Secondary Pass (Pass in 10th or Equivalent from a recognized University).
2. Coordinator
 - Only for Indian Citizen.
 - Sr. Secondary Pass (Pass in 12th or Equivalent from a recognized University).

AGE LIMIT:

- The cut-off date of minimum and maximum age limit for appointment to all posts will be 15/03/ 2026.
- For the above posts, the minimum age of candidates of all castes should be 18 years by 15/03/2026. Otherwise, the application form of candidates below 18 years of age will be considered rejected.
- For all the above posts, maximum age for Unreserved (Male) – 37 years, Backward Class/Extremely Backward Class (Male and Female) and Unreserved Female – 40 years and SC/ST (Male and Female) – 42 years.
- The retirement age of selected candidates is fixed at 60 years.

DOCUMENTS REQUIRED:

- Aadhaar Card
- Mark sheet/Certificate
- Passport Size Photo (Colour)
- Signature

MONTHLY SALARY

- Panchayat Teacher – Rs. 13700/ Month.
- Coordinator – Rs. 15900/ Month.
- The salary increase will be in the form of 8% increase in fixed salary after 1 year. Salary will be paid by CTC into the employee's bank account from 01st to 05th of every month.
- Panchayat Teacher/Coordinator will be added to the service under National Pension System (NPS).

HOLIDAYS:

- Apart from all government holidays, Panchayat teachers and coordinators will be given weekly leave and 16 days' casual leave in a year.
- If the Panchayat teacher and coordinator is a woman, then in addition to all the leaves given above, additional maternity leave of 90 days will be given.

SELECTION PROCESS

After the preparation of merit list, the candidates will be selected on the basis of their merit through District, Block and Panchayat Wise Telephonic interview.

Candidates of all castes will submit their application completely free of cost. No fee will have to be deposited to the department for this application. If the candidate gives any money in the name of fee, it will be the full responsibility of the candidate.

Important Instructions

- After filling the final online application, candidates should download its hard copy from Download Application at the same time and print two copies of the same You must retain copies of all certificates/documents related to the advertisement. The candidate has to submit the said hard copy and all relevant certificates at any time or as per the requirement demanded by the department.

The total posts given by the department for different states are given in the table above, in which 60% posts have been reserved for Female and 40% posts have been reserved for Male.

Necessary (detailed) instructions regarding filling of online application are displayed on the official website of the Commission www.rsvk.in

Before filling the online application, candidates should study the above guidelines thoroughly and enter all the information correctly and clearly while filling the online application.

Before applying, candidates should ensure that all the information entered in the application is correct. If any error is found in the entry made in the application, it will not be rectified under any circumstances.

After submitting the application form, candidates will immediately download the filled application form. There is no provision to edit any line after completing the online application.

The Commission will not be responsible for not following the necessary (detailed) instructions for filling the online application and for any error in the entries made by the candidate while filling the online application. If any error is found while matching the information filled in the online application with the original certificate/mark sheet, then the candidature will be canceled.

It will be the responsibility of the applicant to keep the E-mail Id and Mobile Number mentioned in the online application safe. Through this the candidate will be given information about the appointment process. Candidates will enter their current Mobile number and E-mail Id while filling the online application. Do not under any circumstances use another person's Mobile number and E-mail Id.

- By applying online, it will not be assumed that the appointment of the candidate is assured.
- Candidates should ensure to upload their clear photograph while applying online.
- Candidates will scan the signature in Hindi or English and upload it in the prescribed space in the online application. Candidates shall satisfy themselves that the uploaded signature image is clear.
- The applicant should also ensure that the registration number is mentioned on the hard copy of the downloaded application.

Apart from this, all the certificates mentioned related to the advertisement will have to be preserved as hard copies of the finally filled online application. It will be mandatory for the candidate to submit the said hard copy and all relevant original certificates when asked by the Commission. The Commission will be free to take a decision regarding the eligibility of the candidates who do not comply with the above instructions.

Under the Rashtriya Shishu Vikas Kendra Panchayat Teacher will be appointed in all the wards of the Panchayat and Panchayat Coordinator will be appointed in all the Panchayat of the State.

- All information related to this advertisement will be published on the department's website www.rsvk.in, there will be no need for separate publication in newspapers.
- Separate printed, typed, handwritten applications other than the prescribed online application for this advertisement will not be accepted and no examination fee will be charged.
- The applicant should fill all the entries in the online application carefully. Any future changes/corrections will not be valid. The department will not be responsible for any kind of error and the applicants themselves will be responsible for any adverse consequences.
- After filling the application form, the applicant should be completely satisfied that all the entries filled by him have been mentioned in the application form. Incompletely filled application form will not be valid and the candidates themselves will be responsible for the same. If any deficiency is found in any entry in the application form, the candidate will not be given an additional opportunity to correct it under any circumstances. If incomplete and incorrect facts/entries filled by the candidate in the application form are found to be wrong during verification, then legal action will be taken against him considering the above act as misconduct and he will be deprived of the recruitment conducted by the department in future.

How to Apply

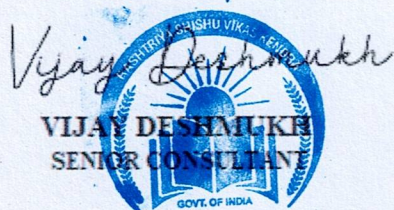
- Candidates should open the official website www.rsvk.in in their browser.
